FIRST-AID MEASURES:

Inhalation: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

Eye contact: Rinse immediately with plenty of water for at least 15 mins. Contact a doctor if symptoms persist.

Skin contact: Remove contaminated clothes. Wash thoroughly with soap & water, flush with plenty of water. If irritation persists, Ingestion: If adverse reaction occurs rinse mouth out with water. Seek medical advice immediately.

2. FIRE FIGHTING MEASURES.

Flashpoint: 33°C

Extinguishing media recommended: Use CO₂, Dry Powder or Foam type of Extinguishers, spraying extinguishing media to base of flames. Do not use direct water jet on burning material.

Special measures: Avoid vapour inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-Extinguishing procedures: Closed containers may build up pressure when exposed to heat and should be cooled with water spray.

3. ACCIDENTAL RELEASE MEASURES.

Personal precautions: Avoid inhalation & direct contact with skin & eyes. Use individual protective equipment (safety glasses, waterproof-boots, suitable protective clothing) in case of major spillages.

Environment precautions: Keep away from drains, soils, surface & groundwaters.

Cleaning up methods for spillages: Remove all potential ignition sources. Contain spilled material. Cover with an inert or no n-combustible inorganic absorbent material, or sweep up and remove to an approved disposal container. Observe state, federal & local disposal regulations.
